AN ORDINANCE TO ASSESS PROPERTIES FOR SANITARY SEWER IMPROVEMENT AS A RESULT OF ANNEXATION TO THE CITY OF ALBANY AND DELARING AN EMERGENCY.

RECITALS:

- 1. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinanco No. 2864.
- 2. The sanitary sewers referred to in this ordinance and previous resolutions are known as: South Residential Sanitary Sewer Extension 1, Lehigh Acres Sanitary Sewer and Price's 2nd Addition Sanitary Sewer Extension.
