TITLE: An Ordinance providing forthe calling of a special election within the City of Albany, Oregon, on November 5, 1968, for the purpose of submitting to the legal voters of the City of Albany, Oregon, the question of amending Section 3 of Chapter 1 of the Charter of the City of Albany, Oregon, so as to re-establish the boundaries of the said City and declaring an emergency.

RECITALS:

whereas, the boundary of the City of Albany has been changed since the last adoption of the Charter through various annexation proceedings and it is in the best interest of the people of the City of Albany that the boundary lines be redefined and set forth in the Charter as a part thereof, now, therefore,

THE PEOPLE OF THE CITY OF ALBANY, OREGON DO ORDAIN AS FOLLOWS:

Section 1: SPECIAL ELECTION CALLED

The proposition set forth in Section 2 of this Ordinance shall be submitted in the manner described in this Ordinance to the legal voters of the City of Albany, Oregon, at a special election to be held on the 5th day of November, 1968. This is a state wide general election being held in the State of Oregon and in the City of Albany as a part thereof, on the 5th day of November, 1968, and this special election is called to be held concurrently therewith.

Section 2: PROPOSITION TO BE VOTED

At the election as shall be submitted to the legal voters of the City of Albany for their approval or rejection, the following proposition:

"Shall Section 3 of Chapter 1 of the Charter of the City of Albany be amended to include the present description of the exterior boundaries of the City and include therein all properties which are now presently surrounded by properties within the City of Albany."

Section 3: DESIGNATION OF POLLING PLACES, POLL BOOKS AND JUDGES

The regular polling places so designated by the County Court of Linn County, Oregon, and the voting precincts in the City of Albany are hereby designated as the polling places for the special city election. The poll books adopted by the County Court of Linn County, Oregon, as the poll books for the state wide general election for the voting precincts in the City of Albany hereby are adopted as the poll books for the special election within the maid City, the judges and clerks of the election appointed by the County Court of Linn County, Oregon, to serve the state wide general election hereby are designated as the judges and clerks of and for the special election.

Section 4: HOURS OF MINISTION

The polls for the special city election shall be open in each of the voting precincts at the same hour and shall be kept open until the same hours the polls are opened and closed for the state wide general election and will be held on the same date.

Section 3: NOTICE OF ELECTION

Notice of election shall be given by publication twice in a newspaper of general circulation in the City of Albany, Oregon, not more than twenty (20) nor less than ten (10) days before the election. Notice of the election shall be posted for not less than twenty (20) days before the election and in three (3) public places within the City. Notices in the newspaper and those posted in three (3) public places shall be substantially in the following form:

"NOTICE OF SPECIAL ELECTION. On the 5th day of November, 1968, in the City of Albany, Linn County, Oregon, from 8 o'clock a.m. until 8 o'clock p.m., a special election shall be held at which time the following measure shall be submitted to the voters for their approval:

'Shall Section 3 of Chapter 1 of the Charter of the City of Albany be amended to include the present description of the exterior boundaries of the City of Albany and include therein all properties which are now presently surrounded by properties within the City of Albany."

The City and the County precincts within the City of Albany, Linn County, Oregon, shall have uniform boundaries and the same election board. The polling places in the City for the special city election shall be at the same places provided for by the County of Linn for state wide general election to be held on the same day. The City Council, by Ordinance, has appointed the identical officers appointed by the County Court of Linn County, Oregon, for the state wide general election as the judges and clerks for the special city election to serve in each of the polling places in the respective precincts for which they are appointed by the County Court of Linn County.

The Recorder shall advertise and post or cause to be posted the notice as required by this Ordinance. The notices of election required to be given by this Ordinance shall constitute the only notice necessary and all Ordinances or Resolutions in conflict herewith shall nullify the notices required to be given of this election.

Section 7: EMERGENCY CLAUSE

WHEREAS, it is necessary that an election be called to be held concurrently with the primary general election in the State of Oregon, an emergency is hereby declared to exist and this Ordinance shall be in full force and effect upon the passage by the Council and approval by the Mayor.
