AN ORDINANCE RELATING TO DISPENSING WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER ORS. 222.111, 222.120 AND 222.170 REGARDING THE CONDITIONAL ANNEXATION OF CERTAIN PROPERTY LOCATED SOUTH OF 34TH AVENUE, ADJACENT TO EAST SIDE OF PACIFIC BOULEVARD, LINN COUNTY, OREGON AND DECLARING AN EVERGENCY.

WHEREAS, on the 9th day of April, 1969, there was filed with the City Recorder of the City of Albany, a petition and consent by the Petitioners, representing to be the owners of property contiguous to the City of Albany, Oregon, to elect to dispense with an election within the City of Albany concerning the annexation of said property and setting a date for the hearing of the same.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY

That an election within the City of Albany regarding the annexation of the following described property to-wit:

As a M-2 Zone

shall be and is hereby dispensed with.

Section 2: HEARING

That there shall be a Public Hearing as to the advisability of annexing the property described in Section 1 to the City of Albany, Oregon, on the 14th day of May, 1969, and the City Recorder is hereby directed to give Notice of Public Hearing by publishing in a newspaper of general circulation published in the said City once (1) a week for two (2) successive and consecutive weeks and by posting in four (4) public places a Notice setting forth the time and place of the said hearing, the purpose for which the hearing is to be heard, and the description of the property to be considered for annexation on the following basis:

Section 3: EMERGENCY CLAUSE

WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and should the same be annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this Ordinance shell become immediately effective upon its passage by the Council and approval by the Mayor.
