AN ORDINANCE ELECTING TO DISPENSE WITH AN ELECTION WITHIN THE CITY OF ALBANY, OREGON, UNDER THE FROVISIONS OF ORS SECTION 222.111, 222.120 AND 222.170, REGARDING THE ANNEXATION OF AN AREA LOCATED AT THE MORTHWEST CORNER OF WAVERLY DRIVE AND RIVER AVENUE, CONTIGUOUS TO THE CITY OF ALBANY, SETTING A TIME FOR PUBLIC HEARING ON THE SAME AND DECLARING AN EMERGENCY.

WHIREAS, 100 per cent of the owners of the property which is the subject matter of this annexation have petitioned and requested the City of Albany to annex the area hereinafter described to the City of Albany, and the same being contiguous and in all respects qualifying under present statutes; for annexation, and

WHEREAS, it is in the best interest of the City of Albany that a public hearing be held at the earliest possible date to consider objections to the annexation of the property herein described.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DESCRIPTION OF PROPERTY.

That an election within the City of Albany regarding the annexation of the following described property to-wit:

Baap at the intersection of the N li of Burkhart Park Add. a subdivision of record, Li Co., O, with the c/l of Cox Creek and rng then S $88^{\circ}37'$ W 469.48 ft to the SW cor of that tract of land descd in deed bk 281, pg 96, sd records; th N Ol°39' W alg the W li of sd tract, 380 ft, m/l to the c/l of sd Cox Creek; th SELy alg the c/l of sd creek to the pob, containing 2.2 acres m/l. (ll 3W 5A 101) Also:

Beg at the SE cor of that tr of land conveyed to O. L. Bowman by deed as recorded in Bk 222, pg 427, Li Co., O, Dd Rcds; sd pt being N Ol°39' W 60.0 feet and E 43.86 ft from the NW cor of Lt 4, Blk 27, Burkhart Park Add, a subdivision of record; # rnng th S 88°37' W alg the S li of sd Bowman Tr, 753.86 ft, more or less, to the intersection of sd li with the ext of the E li of Lt 1, Blk 19, sd Burkhart Park Add; th N Ol°39' W 400.0 feet; th N 88°37' E 753.86', more or less, to a pt on the E li of sd Bowman Tr; th S Ol°39' E alg sd E li 400.0 ft to the pob, containing 6.92 acres m/1 (11 3W 5A 301)

As M-3 Industrial Zone

be dispensed with.

Section 2: HEARING

That there shall be a public hearing as to the advisability of annexing the property described in Section 1 to the City of Albany, on the 27th day of August, 1969, at 7:15 p.m. o'clock, and the City Recorder is hereby directed to give notice of said public hearing by publishing in a newspaper of general circulation, published in the said City once a week for two (2) successive and consecutive weeks and by posting in four (4) public places, a notice setting forth the time and place of said hearing and the description of the property to be considered for annexation and the purpose for which the hearing is held.

Section 3: EMERGENCY CLAUSE.

WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and, should be same be annexed, that the City facilities be made available to this property, therefore, an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
