TITLE:

An ordinance regulating dances, dance halls, requiring a license for operating a dance for profit, providing penalty for violation hereof and repealing all ordinances, or parts of ordinances in conflict and declaring an emergency.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: DEFINITIONS-EXEMPT AND NON-EXEMPT DANCES

The term "Exempt Dance" shall include all public dances not held in a private residence, by school officials or by Church authorities on their premises.

The term "non-exempt Dance" shall include all public dances either for profit or not for profit conducted in a public or private place and not exempt in Section #1.

The term "Dance Hall" shall be construed to mean any hall, pavillion, room or place, except a private residence, church, or school building in which a dance is held.

Section 2: INSPECTION

All dances shall be open for inspection by any police officer of the City of Albany at any and all times.

Section 3: LOITERING

It shall be the duty of every person giving or conducting a dance to conduct the same in a proper and decorous manner. He shall not permit or allow any person under the influence of intoxicating liquor to be or remain within the dance hall, or any hallway or stairs leading thereto or any anteroom.

Section 4: CLOSING HOURS

All dances which shall be open to persons under 18 years of age shall be subject to the following closing times:

a) Sunday nights through Thursday nights - 10:00 p.m.

b) Friday nights and Saturday nights - 11:30 p.m.

Closing for later hours may be allowed upon previous written permission granted by the Chief of Police, but in no event shall permission be granted to extend closing beyond 12:00 midnight.

Section 5: AGE REQUIREMENT

It shall be unlawful to permit or suffer any person under the age of 15 years to take part in any dance or to remain in any dance hall unless accompanied by a parent or guardian. The person in charge of admission shall require valid proof of age.

Section 6: LIQUOR

It shall be unlawful for any person under the influence of intoxicating liquor to enter any dance hall or hallway or anteroom leading thereto or remaining therein during the progress of any dance.

Section 7: CHARITABLE OR NON-PROFIT DANCES

The Chief of Police may grant a permit for the giving of a dance which shall not be for profit and which shall allow the admission of minors 15 years of age or less on the following conditions:

a) That no minor over the age of 18 years shall attend the said dance unless it shall be in a supervisory capacity as a chaperon;

b) Closing time from Sunday nights through Thursday nights shall be 9:30 p.m. and Friday night and Saturday night 11:00 p.m.;

c) The permit shall state the names and addresses of at least I adult male chaperone and I adult female chaperone, and they shall be present at the dance;

d) Application for a dance permit shall be made at least 3 days prior to the dance.
