## ORDINANCE NO. 3458

AN ORDINANCE VACATING A PORTION OF HOOD STREET BETWEEN BLOCKS 9 and 10, WINONA PARK ADDITION TO CITY OF ALBANY; ALLEY IN CENTER OF BLOCK 9, WINONA PARK ADDITION AND TWELVE (12) FOOT STRIP FROM HOOD STREET TO ALLEY ON NORTH LINE OF BLOCK 9, WINONA PARK ADDITION.

WHEREAS, the City Council of the City of Albany, did, by adoption of Resolution No. 1216, City of Albany Resolutions, at the Council meeting on the 12th day of November, 1969, set the hour of 7:15 p.m. o'clock on the 22nd day of December, 1969, as the time for hearing of objections to the proposed vacation of a portion of Hood Street between Blocks 9 and 10, Winona Park Addition, City of Albany, alley in center of Block 9, Winona Park Addition and a twelve foot strip from Hood Street to alley on North line of Block 9, Winona Park Addition, City of Albany, as hereinafter described, and did direct the City Recorder to publish and post notice of the said proposed vacation as required by law, and

WHEREAS, the said notice has been posted and published as required by law, and

WHEREAS, the said hearing on the 22nd day of December, 1969, has been duly held and parties were given an opportunity to be heard and the Council being fully informed,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That a portion of Hood Street from Southern Pacific Railroad property South to 12th Avenue between Blocks 9 and 10, Winona Park Addition, City of Albany, Linn County, Oregon; ALSO: Alley in center of Block 9, Winona Park Addition; ALSO: Twelve (12) foot strip from Hood Street to alley on North line of Block 9, Winona Park Addition; SUBJECT to RESERVING the following 10 foot sanitary sewer easement in vacated alley in Block 9, Winona Park Subdivision, the center line of said easement being described as follows: Beginning at a point which is on the south line of Block 9, and 8 feet east of the southeast corner of Lot 2, Block 9, Winona Park, a subdivision of record, said point being further described as on the south line and in the center line of a vacated alley way through Block 9 of said subdivision, thence northerly parallel to the east line of said Lot 2, 162 feet to the north line of the above mentioned subdivision; be and the same are hereby vacated.

Section 2: This Ordinance vacating the above entitled street, 12 foot strip and alley shall become effective upon the filing of a petition to improve 12th Avenue from Thurston Street to the center of the alley between Hood and Lafayette Streets within the City of Albany.
