

ORDINANCE NO. 3473

TITLE: AN ORDINANCE VACATING A PORTION OF A PLAT KNOWN AS RODGERSDALE AS SHOWN IN THE LINN COUNTY PLAT RECORDS, FILED MARCH 14, 1956, IN VOLUME II, PAGE 46, AND DECLARING AN EMERGENCY.

RECITALS:

WHEREAS, the Council of the City of Albany did by Resolution No. 1231, passed by the Council at the Council meeting on the 11th day of February, 1970, set the hour of 7:15 p.m. on the 25th day of March, 1970, as the time hearing of objections to the proposed vacation of a portion of a plat known as Rodgersdale, as shown in the Linn County, Oregon Plat Records filed March 14, 1956, Volume 11, Page 46, more particularly described as follows:

Lots 3 through 10, Block 15, Blocks 19, 21, 22, 25 and 27 and Lots 7, 8, 9, and 10 in Block 16, Rodgersdale Addition to the City of Albany, Linn County, Oregon; RESERVING, a storm sewer easement to the City of Albany by Deed Book 326, Page 130, Linn County Deed Records, and

WHEREAS, notice has been posted and published as required by law in the said Resolution, and

WHEREAS, a hearing was held on the 25th day of March, 1970, and no remonstrances was filed with the City Recorder, no persons appearing objecting to the proposed vacation of plat described herein, now, therefore,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1:

That the portion of a plat known as Rodgersdale Addition, as shown in the Linn County, Oregon, Plat Records filed March 14, 1956, Volume 11, Page 46, more particularly described as follows:

Lots 3 through 10, Block 15, Lots 7, 8, 9, and 10, Block 16, Blocks 19, 21, 22, 25 and 27, Rodgersdale Addition to the City of Albany Linn County, Oregon; RESERVING, a storm easement to the City of Albany, by Deed Bk. 326, Page 130, Linn County Deed Records

be and the same is hereby vacated.

Section 2:

Inasmuch as the provisions of this Ordinance are necessary for the immediate preservation of the peace, health and safety of the citizens of the City of Albany, an emergency is hereby declared to exist and this ordinance shall be in full force and effect immediately upon its passage by the Council and approval by the Mayor.
