### ORDINANCE NO. 3527

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY STOCK SEVER IMPROVEMENT TO SERVE LOTS 4 THROUGH 8 OF BLOCK 9 AND LOTS 1 THROUGH 4, BLOCK 11, JEFFERY 4TH ADDITION SD 70-2, AND DECLARING AN EMERGENCY.

#### RECTTALS:

- 1. The never assessments as referred to in this ordinance and previous resolutions and ordinances is for SD 70-2 Storm Sewer to serve Lots 4 through 8 of Block 9 and Lots 1 through 4 of Block 11, Jeffery 4th Addition.
