TITLE: ZONE CHANGE AMENDMENT NO. 90 UNDER ORDINANCE NO. 2916, REZONING AN AREA FROM 24TH AVENUE TO 34TH AVENUE FROM MARION STREET TO HILL STREET TO R-6 RESIDENTIAL ZONE

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: ZONE CHANGE AMENDMENT NO. 90

The following described property is hereby rezoned to R-6 Residential

Zone.

Beginning at the intersection of the West line of Hill Street and the South line of 24th Avenue and running thence South along the West line of Hill Street to its intersection with the North line of 34th Avenue; thence Westerly along the North line of 34th Avenue to the West boundary line /of Rodgersdale Addition; thence North along the West line of Rodgersdale Addition to its intersection with the South line of 30th Avenue extended Easterly; thence West along said extension and the South line of 30th Avenue to the East line of Marion Street; thence North along the East line of Marion to its intersection with the South line of 27th Avenue; inence has along the South line of 27th Avenue to its intersection with the Southerly extension of the West line of Block 5, Cascade View Addition; thence North along said extension and the West line of said Block 5 to its intersection with the South line of Block 2, Cascade View, said point also being on the North line of 26th Avenue; thence West along said North line of 26th Avenue to its intersection with the East line of Jackson Street; thence North along said East line to its intersection with the North line of 25th Avenue; thence West along the North line of 25th Avenue to the East line of Marion Street; thence Northerly along the East line of Marion Street to the South line of 24th Avenue; thence Easterly along the South line of 24th Avenue and its extension thercof to the East line of Jackson Street; thence North along the East line of Jackson Street to the South line of 24th Avenue; thence Easterly along the South line of 24th Avenue to its intersection with the West line of Hill Street, said point also being the point of beginning

All of the above entitled property was R-5 Residential zone except Block 61 and Block 62, Goltra Park Addition and that portion of vacated Railroad Street adjacent to Goltra Park Addition, which areas were R-A Multiple Family Zones. This amendment shall be known as Zone Change Amendment No. 90. <u>Section 2</u>: A copy of this zone change amendment shall be filed in the office of the City Recorder of the City of Albany and the number shall be noted on the official zoning map of the City of Albany.
