## ORDINANCE NO. 3589

TITLE:

ZONE CHANGE AMENDMENT NO. UNDER ORDINANCE NO. 2916, REZONING AN AREA LOCATED FROM THIRD TO NINTH AVENUES, WASHINGTON TO ELM STREETS TO R-1 (6) RESIDENTIAL ZONE WITH CERTAIN EXCEPTIONS AND ESTABLISHING EFFECTIVE DATE

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: ZONE CHANGE AMENDMENT NO. 92

The following described property is hereby rezoned to R-1(6) Residential Zone.

R-1 (6) Single Family Residential - 3rd Avenue to 9th Avenue from Elm to Washington

• Beg at the intersection of the S line of 3RD Avenue with the W line of Washington St and running th S along the W line of Washington St to its intersection with the N line of 9TH Avenue; th W along the N line of 9TH Avenue to the E line of Elm St; the N along the E line of Alm St and its E line extended N to the S line of the Calapooia River; th meandering NEly, SEly and NEly to a pt where the S line of sd river intersects with the S line of 3RD Avenue; th E along sd 3RD Avenue extension and the S line of sd 3RD Avenue to its intersection with the W line of Washington St, the pt of beginning.
