ORDINANCE NO. 3754

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITTED BY STREET IMPROVEMENTS, ST-73-28, JACKSTON STREET - 24TH TO 25TH, AND ST-73-32 - 19TH AVENUE - MAIN TO THE EAST AND DECLARING AN EMERGENCY.

RECITALS:

- 1. The street assessment as referred to in this ordinance and previous resolutions and ordinances are the street improvements to serve ST-73-28, Jackson Street 24th to 25th, and ST-73-32 19th Avenue Main to the east.
- 2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvements are set forth in Resolution Nos. 1392 and 1541.
- 3. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance No. 2864.
