ORDINANCE NO. 3775

ORDINANCE AMENDING SECTION 2.08.040 OF THE ALBANY MUNICIPAL CODE PROVIDING FOR THE DIVISION OF THE CITY INTO THREE WARDS AND DESIGNATING THE BOUNDARIES OF EACH WARD.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1:

Section 2.08.040 of the Albany Municipal Code is hereby amended to read as follows:

"2.08.040 Wards. For the purpose of municipal representation, the city is hereby divided into three wards designated and bounded as follows:

Ward I is hereby declared to include all of that property of the city west of the following line: Beginning at the north end of Thurston Street in the city of Albany; thence southerly along the westr.o.w. of Thurston Street to 8th Avenue; thence westerly along the centerline of 8th Avenue to the westrowline of the Southern Pacific Mainline Railroad Tracks between San Francisco and Portland; thence southerly along the westr.o.w. of the Southern Pacific Mainline Railroad Tracks to the intersection of the southerly city limits of the city of Albany.

Ward II is hereby declared to include that property that is in the following area: Beginning at the intersection of the center of S. Columbus St. and the north line of the Southern Pacific Railroad tracks between Albany and Lebanon; thence northerly abng the centerline of S. Columbus Street to the north line of Albany-Santiam canal; thence westerly along the north line of said canal to its intersection with the centerline of Geary Street; thence northerly along the center line of Geary Street to the centerline of 8th Avenue (Pacific Boulevard); thence westerly along the centerline of 8th Avenue (Pacific Boulevard) to the intersection of 8th Avenue (Pacific Boulevard) and the west row. of the Southern Pacific Railroad Mainline Tracks between San Francisco and Portland; thence southerly along the west row. of the Southern Pacific Railroad Mainline Tracks to the southern city limits of the city of Albany; thence easterly along the southern city limits of the city of Albany to the point of beginning.

Ward III is hereby delcared to include all of that property of the city that lies east of the following described line: Beginning at the intersection of the centerlin e of Thurston Avenue and the northerly city limits of the city of Albany proceeding thence southerly along the centerline of Thurston Avenue to the intersection of the centerline of 8th Avenue (Pacific Boulevard); thence easterly along the centerline of 8th Avenue to the centerline of Geary Street; thence southerly along the centerline of Geary Street to the north line of the Albany-Santiam Canal; thence easterly along the north line of said canal to its intersection with the centerline of S. Columbus; thence southerly along the centerline of S. Columbus to the north right-of-way line of the Southern Pacific Railroad tracks between Albany and Lebanon.
