ORDINANCE NO. 3784

AN ORDINANCE AMENDING SECTIONS 4 and 5 OF ORDINANCE NO. 3773 PROVIDING FOR THE ISSUANCE AND SALE OF IMPROVEMENT BONDS OF THE CITY OF ALBANY IN THE AMOUNT OF \$805,000.00, PROVIDING FOR MATURITY DATES AND THE FORM OF BOND TO BE USED AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Section 4 of Ordinance No. 3773 is hereby amended to read as follows:

"Section 4: That the City Recorder be, and he hereby is instructed and directed to have prepared and printed a sufficient number of bonds, in denominations not to exceed \$5,000.00 each, and in all equal to said sum of \$805,000.00, such bonds to be dated May 1, 1974 and to mature in annual installments as follows:

Said bonds shall bear interest from the date thereof at a rate or rates not to exceed seven percent (7%) per annum, or such lesser rates as the common council shall prescribe, payable semi-annually at the office of the Recorder of the City of Albany, Oregon and said bonds shall, for convenience and identification, be denominated "City of Albany Improvement Bonds, Issue 1974" and shall be numbered consecutively and the number and name of each bond shall be printed thereon, and such bonds shall be signed by the Mayor of the City of Albany and countersigned by the Recorder."

Section 2: That Section 5 of Ordinance No. 3773 is hereby amended to read as follows:

"Section 5: That the said City of Albany Improvement Bonds, Issue 1974 shall be substantially in the following form.

	in lawful money of the United States of America on the presentation and surrender of this obligation on the first day of, 19, without grace, with interest thereon from the date hereof until redeemed at the rate of percent (%) per annum, payable semiannually on the first days of and each year on the presentation and surrender of the proper coupons hereto annexed, principal and interest payable at the office of the City Recorder of the City of Albany, Oregon.		
	This Bond is one of a series of Bonds authorized by and under the provisions of the Charter of said City and 223.205 et. seq. Oregon Revised Statutes, providing for the issuance of bonds for street, sidewalk and sewer improvements and for the payment of the cost of such improvements, and is an obligation of the City of Albany, and is within every debt limitation of said City, and it is further certified that all of the requirements of law have been fully complied with by the proper officers in the issuance of this bond.		
	For the fulfillment of the conditions of this obligation the full faith and credit of the City of Albany hereby are irrevocably pledged.
