## ORDINANCE NO. 3802

AN ORDINANCE ANNEXING A PARCEL OF PROPERTY LOCATED AT THE NORTHEAST CORNER OF 36TH AVENUE AND HIGHWAY 99E, AS R-1 (6) RESIDENTIAL DISTRICT AND DECLARING AN EMERGENCY."

WHEREAS, on the 31stday of July , 1974, at a special Council meeting, the Council of the City of Albany, Oregon, did duly pass Ordinance No. 3798, wherein it was provided that a public hearing would be held on the 14th day of August , 1974, concerning the advisability of annexing a parcel of property located at the northeast corner of 36th Avenue and Highway 99E, As R-1 (6) Residential District, and

WHEREAS, the hearing was duly held on the 14th day of August .1974, and at that time the Council determined that the Notices of Hearing had been given as provided in the said Ordinance, and pursuant to the terms of ORS 222.111, 222.120 and 222.170, and

WHEREAS, the Council after said hearing determined that the area described herein as located at the northeast corner of 36th Avenue and Highway 99E, as R-1 (6) Residential District should be annexed.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 3: WHEREAS, it is in the betterment of the public health, interest, safety and general welfare of the citizens of the City of Albany that this matter of annexation of the property described herein be disposed of at the earliest possible moment, and that the City facilities be made available to this property; therefore, an emergency is hereby declared to exist and this Ordinance shall become immediately effective upon its passage by the Council and approval by the Mayor.
