## ORDINANCE NO. 3823

AN ORDINANCE ANNEXING AN AREA LOCATED EAST OF INTERSTATE 5 AND SPICER ROAD AS C-2 COMMERCIAL AND DECLARING AN EMERGENCY.

<u>Section 1</u>: That the following described property be and is hereby annexed to the City of Albany, to-wit:


