ORDINANCE NO. 3826

AN ORDINANCE VACATING A PORTION OF ERMINE FROM 36TH TO WESTWOOD PLACE EXCEPTING THAT CERTAIN PORTION WHICH SHALL BE MAINTAINED BY THE CITY OF ALBANY AS A PEDESTRIAN WALKWAY-BICYCLE PATH.

WHEREAS, the City Council of the City of Albany, did, by adoption of Resolution No. 1648, City of Albany Resolutions, at the Council meeting held on the 13thday of Nov., 1974, set the hour of 7:15 p.m. o'clock on the 8th day of January , 1975, as the time for hearing of objections to the proposed vacation of a portion of Ermine from 36th to Westwood Place excepting that certain portion which shall be maintained by the City of Albany as a pedestrian walkway - bicycle path.

WHEREAS, the said notice has been posted and published as required by law, and

WHEREAS, the said hearing on the 8th day of January , 1975, has been duly held and parties were given an opportunity to be heard and the Council being fully informed,

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1:

"That 50' of Ermine from 36th to Westwood Place be and is hereby vacated, such J0' to be maintained as a permanent utility easement by the City of Albany, and that the center 10' of deemed right-of-way be permanently maintained as a pedestrian walkway-bicycle path.

Resolution 1648 VACATIONING A PART OF ERMINE STREET

Beginning at a point S. 1⁰37'00" E. 178.84 ft. from the initial point of the Case Addition in Sec. 17, T. 11 S., R. 3 W., W.M. in Linn County, Oregon.

Thence S. 1⁰37'00" E. 102 ft. more or less to the north right-of-way line of 36th Avenue;

Thence S. 88⁰23'00" W. 60 ft. to the west right-of-way line of Ermine Street;
