ORDINANCE NO. 3848

TITLE:

AN ORDINANCE AMENDING ORDINANCE NO. 2740, ALSO CITED AS ALBANY MUNICIPAL CODE SECTION 17.12.010 TO CHANGE THE BOUNDARIES OF FIRE ZONE NO. 1.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1:

Section 4a of Ordinance No. 2740, also designated as 17.12.010 of the Albany Municipal Code is hereby amended to read as follows:

"17.12.010. FIRE ZONE NUMBER 1. Fire Zone number 1 in the city shall be bounded as follows:

Beginning on the south bank of the Willamette River at the northerly extension of Calapooia Street; thence southerly along the east side of Calapooia Street to the north boundary of Third Avenue; thence easterly along the north boundary of Third Avenue to the east boundary of Washington Street; thence southerly along the east boundary of Washington Street to the north boundary of Fourth Avenue; thence easterly along the north boundary of Fourth Avenue to the east boundary of Ferry Street; thence southerly along the east boundary of Ferry Street to the north boundary of Fifth Avenue; thence easterly along the north boundary of Fifth Avenue to the west boundary of Baker Street; thence northerly along the west boundary of Baker Street to the north boundary of Fourth Avenue; thence easterly along the north boundary of Fourth Avenue to the west boundary of Montgomery Street; thence northerly along the west boundary of Montgomery Street to the north boundary of Third Avenue; thence easterly along the north boundary of Third Avenue to the west boundary of Railroad Street; thence northerly along the west boundary of Railroad Street to the south boundary of Water Street; thence northwesterly to the southeast corner of Block 100, Hackleman's Addition; thence northerly to the bank of the Willamette River; thence westerly along the river to the point of beginning. EXCEPTING therefrom the property described as follows: Beginning at the intersection of the centerline of Ellsworth Street with Water Avenue; thence westerly along the centerline of Water Avenue to its intersection with Broadalbin Street; thence northerly along the centerline of Broadalbin Street and the northerly extension of the centerline of Broadalbin Street to the centerline of the Willamette River; thence easterly

along the centerline of the Willamette River to its intersection with the extension of the centerline of Ellsworth Street; thence southerly along the extension and along the centerline of Ellsworth Street to the point of beginning.
