ORDINANCE NO. 3859

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITTED BY SEWER IMPROVEMENTS, SS-75-2 WHITE TRUCK SANITARY SEWER AND DECLARING AN EMERGENCY.

RECITALS:

- 1. The sewer assessment as referred to in this ordinance and previous resolutions and ordinances are the sanitary sewer to serve the Oregon White Truck property.
- 2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvements are set forth in Resolution Nos.
- 3. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance No. 2864.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:
