ORDINANCE NO. 4084

TITLE: AN ORDINANCE FIXING INTEREST RATES UPON THE CITY OF ALBANY, OREGON IMPROVEMENT BOND, SERIES 1977B, DATED DECEMBER 15, 1977, IN THE PRINCIPAL SUM OF \$300,000 AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: RATE OF INTEREST.

The rate of interest payable semi-annually upon the City of Albany, Oregon Improvement Bond Issue 1977B, in the principal sum of \$300,00 par value to be dated December 15, 1977, and to mature serially in the years 1978 through 1987, inclusive, will be <u>4.7981</u> % per annum as specified in the offer of The Oregon Bank
