ORDINANCE NO. 4156

TITLE: AN ORDINANCE AFFIXING INTEREST RATES UPON THE CITY OF ALBANY OREGON IMPROVEMENT BOND SERIES 1978A DATED AUGUST 15, 1978 IN THE PRINCIPAL SUM OF \$450,000 AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY, OREGON DO ORDAIN AS FOLLOWS:

Section 1: Rate of Interest. The rate of interest payable semi-annually upon the City of Albany, Oregon Improvement Bond Issue 1978A, in the principal sum of \$450,000 par value to be dated August 15, 1978, and to mature serially in the years 1979 through 1988 inclusive, will be 5.39181 % per annum as specified in the offer of __The Bank of California

as follows:
