

ORDINANCE NO. 4368

AN ORDINANCE AMENDING ORDINANCE NO. 4321 SEGREGATING THE LIENS OF LUCILLE N. FULTON AND JOHN AND GEORGIA H. FULTON AND DECLARING AN EMERGENCY.

Whereas, Lucille N. Fulton and John and Georgia H. Fulton were assessed for street improvements under Ordinance No. 4321 for ST-78-10 as follows:
