ORDINANCE NO. 4382

AN ORDINANCE AMENDING ORDINANCE NOS. 3655, 3664, 3672, 3675, 3713, 3805, 3806, AND 3829, WHICH DETERMINED THE PENDING ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITED BY IMPROVEMENTS FOR SS-72-8, SS-72-10, ST-72-19, ST-72-20, SS-73-1, ST-73-13, SS-74-2, AND ST-74-4, AND LEVYING REASSESSMENTS FOR THESE PROPERTIES AND DECLARING AN EMERGENCY.

RECITALS:

- 1. The properties described herein were assessed for pending assessments for public improvements for SS-72-8, SS-72-10, ST-72-19, ST-72-20, SS-73-1, ST-73-13, SS-74-2, and ST-74-4 by Ordinance Nos. 3655, 3664, 3672, 3675, 3713, 3805, 3806, and 3829.
- 2. These pending assessments are being reassessed and are due and payable by virtue of annexation under Ordinance No. 4350, which became effective June 12, 1980.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: Ordinance Nos. 3655, 3664, 3672, 3675, 3713, 3805, 3806, and 3829 are hereby amended to reassess the properties described herein as follows:
