ORDINANCE NO. 4393

AN ORDINANCE TO DETERMINE THE ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITED BY SEWER IMPROVEMENTS FOR SS-79-4, ALANDALE 1ST ADDITION, AND DECLARING AN EMERGENCY.

RECITALS:

- 1. The sewer assessments as referred to in this ordinance and previous resolutions and ordinances are for the sewers to serve SS-79-4, Alandale 1st Addition.
- 2. Preliminary resolutions and ordinances prescribing the manner and extent of the improvements are set forth in Resolution Nos. 2076 and 2096.
- 3. The assessments set forth in the following ordinance are based upon the request and recommendation of the City Engineer in compliance with Ordinance No. 2864.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: The costs of the sewers to serve SS-79-4, Alandale 1st Addition, are as follows:

Section 4: Inasmuch as this ordinance is necessary for the immediate preservation of the peace, safety, and health of the City of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon passage by the Council and approval by the Mayor.

Description of Project:

This project provided sanitary sewer service to Alandale 1st Addition and seven adjacent properties.

The project was approved by the City Council on June 13, 1979. Estimated cost was \$99,735.34. The contract was awarded to Cordel Corporation on May 28, 1980. The original contract amount was \$70,220.50. The final contract amount was \$73,138.58.

Method of Assessment:

The benefitting properties shall be assessed on a per lot basis, with the following stipulations:

- 1. If, at any time in the future, the present property owners subdivide their lots into more than one lot, they pay to the owners of property within the assessment district a sum equal to the current assessment of \$1,947.14 per lot for each new lot created. This stipulation shall be effective for ten years from the date of assessment.
- 2. Parcel "A", Alandale 1st Addition shall be assessed at this time. It is possible that Parcel "A" may be dedicated as street right-of-way in the future; however, no reimbursement of assessment shall be made should this occur.

This method of assessment and the stipulations listed were requested by the property owners within the assessment district but outside Alandale 1st Addition and approved by the City Council on August 8, 1979. Further, the Council declined to reopen discussion of these terms (as requested by the developer of Alandale 1st Addition, P & E Land Development) on November 28. 1979.
