AN ORDINANCE TO LEVY AN ASSESSMENT AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY A SEWER CONNECTION AT 2621 27TH AVENUE SE, 2703 28TH AVENUE SE, 2718 BAIN SE, AND 2336 WAVERLY DRIVE SE, AND DECLARING AN EMERGENCY.
