AN ORDINANCE FIXING INTEREST RATES UPON THE CITY OF ALBANY, OREGON, IMPROVE-MENT BOND ISSUE SERIES 1981A, DATED JULY 1, 1981, IN THE PRINCIPAL SUM OF ONE MILLION THREE HUNDRED THOUSAND DOLLARS (\$1,300,000) AND DECLARING AN EMER-GENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1. Rate of Interest.

The rate of interest, payable semiannually, upon the City of Albany, Oregon, Improvement Bond Issue 1981A in the principal sum of ONE MILLION THREE HUNDRED THOUSAND DOLLARS (\$1,300,000) par value to be dated July 1, 1981, and to mature serially in the years 1982 through 1991, inclusive, will be at 9.364347% as specified in the offer of FOSTER AND MARSHALL, INC., as follows:

> \$80,000 on the 1st day of July, 1982. (to bear interest at the rate of 11.50%)

> \$90,000 on the 1st day of July, 1983. (to bear interest at the rate of 11.50%)

> \$100,000 on the 1st day of July, 1984. (to bear interest at the rate of 11.00%)

\$110,000 on the 1st day of July, 1985. (to bear interest at the rate of 9.25%)

\$115,000 on the 1st day of July, 1986. (to bear interest at the rate of 8.75%)

\$135,000 on the 1st day of July, 1987. (to bear interest at the rate of 8.90%)

\$145,000 on the 1st day of July, 1988. (to bear interest at the rate of 9.00%)

\$160,000 on the 1st day of July, 1989. (to bear interest at the rate of 9.20%)

\$175,000 on the 1st day of July, 1990. (to bear interest at the rate of 9.40%)
