ORDINANCE NO. 4462

AN ORDINANCE TO LEVY ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITED BY SEWER CONNECTIONS AT 2607 25TH AVENUE SE, 2514 FULTON STREET SE, 2521 WAVERLY DRIVE SE, 2930 27TH AVENUE SE, AND 2923 27TH AVENUE SE, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:
