## ORDINANCE NO. 4465

AN ORDINANCE TO LEVY ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITED BY SEWER CONNECTIONS AT 2726 27TH AVENUE SE, 2727 27TH AVENUE SE, 2735 27TH AVENUE SE, AND 2516 WAVERLY DRIVE SE, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: The sewer connections as referred to in this ordinance are to provide sewer connections to serve the structures at 2726 27th Avenue SE, 2727 27th Avenue SE, 2735 27th Avenue SE, and 2516 Waverly Drive SE located on the properties described as follows:
