

ORDINANCE NO. 4650

AN ORDINANCE AMENDING ORDINANCE NOS. 4584 AND 4607 WHICH LEVIED ASSESSMENTS AGAINST THE PROPERTY SPECIFICALLY BENEFITED BY A SEWER ASSESSMENT AND SEWER CONNECTION AT 3520 DAVID AVENUE NE, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Ordinance Nos. 4584 and 4607 are hereby amended so as to recognize that the property shall be assessed as a single dwelling unit for a sewer assessment and a sewer connection as referred to in Ordinance Nos. 4584 and 4607 as follows:
