AN ORDINANCE TO LEVY ASSESSMENTS AGAINST THE PROPERTIES SPECIFICALLY BENEFITED BY SEWER CONNECTIONS AT 3496 ELEANOR AVENUE NE, 3471 EARL AVENUE NE AND 250 MARILYN NE AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:
Section 1: The sewer connections as referred to in this ordinance are to provide sewer connections to serve the structures at 3496 Eleanor Avenue $\mathrm{Ne}, 3471$ Earl Avenue NE and 250 Marilyn NE located on the properties described as follows:

Section 2: The sewer connections and the assessments for the same shall be levied according to the provisions of Albany Municipal Code, Section 10.08 .040 and all applicable sections of Chapter 15.08 through 15.12 inclusive.

Section 4: The City Recorder is hereby directed to enter a statement of the assessment as above provided in the docket of the city liens and give notice thereof as provided by law.

Section 5: Inasmuch as this ordinance is necessary for the immediate preservation of the peace, health and safety of the city of Albany, Oregon, an emergency is hereby declared to exist; and this ordinance shall be in full force and effect immediately upon passage by the Council and approval by the Mayor.
