## ORDINANCE NO. 4798

AN ORDINANCE LEVYING A CHARGE UNDER THE PROVISIONS OF CHAPTER 12.14 OF THE ALBANY MUNICIPAL CODE IN LIEU OF ASSESSMENT, SAID PROPERTY BEING DESCRIBED AS TAX LOT 1900, 11-4W-25, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>: A charge is hereby levied against the following described property:
