ORDINANCE NO. 4984

TITLE: AN ORDINANCE AMENDING ORDINANCE NO. 4447, WHICH ADOPTED THE CITY OF ALBANY'S COMPREHENSIVE PLAN AND COMPREHENSIVE PLAN MAPS, THROUGH THE ADDITION OF 90 PROPERTIES TO THE OFFICIAL CITY HISTORIC INVENTORY AND ADOPTING FINDINGS.

WHEREAS, the Landmarks Advisory Commission of the City of Albany has directed an intensive year-long review of significant historic properties located outside the City's National Register Historic Districts; and

WHEREAS, affected property owners have been made aware of the benefits and obligations associated with placement of their property on the inventory and been given the opportunity that historic designation not be pursued at this time, and

WHEREAS, the Landmarks Advisory Commission, following a public hearing on October 15, 1991, recommended that the Albany City Council approve the proposed amendments to the Comprehensive Plan historic resources inventory relative to 20 properties (Case No. CP-01-91a), and

WHEREAS, the Landmarks Advisory Commission, following a public hearing on November 14, 1991, recommended that the Albany City Council approve the proposed amendments to the Comprehensive Plan historic resources inventory relative to 70 properties (Case No. CP-01-91b).

NOW, THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. The official historic inventory of the Albany Comprehensive Plan is hereby amended to include 90 additional properties which are described in the attached Exhibit "A". The City's Historic Review ordinance shall be applied to those appropriately rated properties.

<u>Section 2</u>. The Findings below are hereby adopted in support of this decision:

- A. The Comprehensive Plan Amendment is in compliance with the rules and regulations pertaining to the State Land Use Planning Goal 5 Open Spaces, Scenic and Historic Areas and Natural Resources.
- B. Opportunities have been made to ensure that citizen and agency comments have been solicited throughout the inventory process and all regulations for public notice have been followed.
- C. Inclusion of 90 additional properties on the City's official historic inventory is the result of new inventory update work which has provided the City with better, expanded information about the City's historic resources.
- D. The City of Albany's historic program and expansion and update of its historic inventory has been established in recognition of a public need to protect the City's historic resources.
- E. This Comprehensive Plan Amendment is consistent with the adopted Comprehensive Plan which contains numerous policies relating to supporting identification, recognition, development, and promotion of Albany's historic resources.

<u>Section 3</u>. A copy of this ordinance shall be filed in the Office of the City Recorder of the City of Albany and forwarded to the Department of Land Conservation and Development.
