## ORDINANCE NO. 5134

AN ORDINANCE DECLARING A STREET NAME FOR THE PUBLIC ROAD DEDICATED IN BENTON COUNTY PARTITIONING PLAT NO. 1994-14 AS LISTED BELOW AND DECLARING AN EMERGENCY (FILE NO. SR-06-94 & PA-19-93).

WHEREAS, a public street right-of-way was dedicated as a result of a Partitioning which aligns with Oak Grove Drive NW; and

WHEREAS, a conflict results with the City of Albany addressing grid and the Benton County addressing grid; and

WHEREAS, the US Post Office requested the street name change following the process identified in Section 12.640 of the Revised Albany Development Code.

WHEREAS, staff determined that the street name change was appropriate due to the conflicting street addresses which would hinder mail delivery and emergency response; and

WHEREAS, Building Permits were issued, and the residence is ready for occupancy, all affected parties were verbally notified of the pending street name; and

WHEREAS, notices of the decision will be mailed to affected parties on June 23, 1994 as required by Section 12.630(3a) of the revised Albany Development Code; and

WHEREAS, the Albany City Council on June 22, 1994, voted to approve the proposed Street Name at the request of staff; and

NOW, THEREFORE, THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:


Section 1: That public road lying east of the intersection of Oak Grove Drive NW (County Road No. CR 04440) and Scenic Drive NW (County Road No. CR 14410) is hereby known as OAK GROVE WAY NW.


