AN ORDINANCE AMENDING ORDINANCE NO. 5132 WHICH LEVIED A CHARGE UNDER THE PROVISIONS OF CHAPTER 10.16 OF THE ALBANY MUNICIPAL CODE FOR AN IN-LIEU-OF ASSESSMENT FOR INTERCEPTOR SEWERS FOR SAID PROPERTY BEING DESCRIBED AS TAX LOT #200, OF PARCEL 10-04W-36BC, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF ALBANY DO ORDAIN AS FOLLOWS:

Section 1: That Ordinance No. 5132 is hereby amended so as to amend the acreage transferred from Tax Lot 300, 10-04W-36BC to Tax Lot 200, 10-04W-36BC from 1.359 acres to 1.61 acres and to amend the assessment amount levied, as referred to in Ordinance No. 5132 as follows:
