## RESOLUTION NO. 43 RESOLUTION OF INTENTION TO IMPROVE

BE IT RESOLVED That the Council of the City of Albany, Oregon deems it expedient and proposes to improve Vine Street on the west side of the Mountain States Power water canal between 13th and 14th Streets. in the City of Albany, Oregon, in the following manner, to-wit:

By grading said street to the proper sub-grade.

By paving with suitable hard surface.

3. By laying and constructing concrete gutters where necessary 4. By constructing concrete curbs and sidewalks where necessary

By installing a proper drainage system.

and, further, to improve Walnut Street between 13th and 14th Streets. in the City of Albany, Oregon, in the following manner, to-wit:

By preparation of a sub base of hard surfacing.

Said improvements to be made in accordance with the Charter and Ordinances of the City of Albany, Oregon, and the plans, specifications and estimates were filed in the office of the Recorder of the City of Albany on the 9th day of February, 1949.

The cost of improving the said streets above described and where required by said plans and specifications shall be at the expense of the City of Albany and shall be paid for out of the general fund of said City, the remaining portion of the cost of said improvement of said streets above described shall be assessed on and against the real property adjacent thereto and especially and particularly benefited thereby, as provided by the Charter of said City.

The Engineer's estimate of the total probable cost of the improvement of said Vine Street between 13th and 14th Streets is the sum of \$4,657.90, and the Engineer's estimate of the probable cost of said improvement to be paid by the owners of the real property adjacent thereto and particularly benefited thereby is the sum of \$4,234,45.

The Engineer's estimate of the total probable cost of the improvement of said Walnut Street between 13th and 14th Streets is the sum of \$3,624.40, and the Engineer's estimate of the probable cost of said improvement to be paid by the owners of the real property adjacent thereto and particularly benefited thereby is the sum of \$3,485.00.

The plans, specifications and estimates of Harold Poling, Engineer, for the improvement of Vine Street between 13th and 14th Streets and of Walnut Street between 13th and 14th Streets, are hereby approved and adopted, said plans, specifications and estimates now being on file in the office of the Recorder of said City.

BE IT FURTHER RESOLVED THAT the Recorder of the City of Albany be and he is hereby ordered and directed to give notice of said proposed improvement of Vine Street between 13th and 14th Streets and of Walnut Street between 13th and 14th Streets, as hereinbefore provided, for the time and in the manner as provided by law and the Charter of Estant-Councilman the City of Albany.
