The form of notice as given by the City Recorder of the City of Albany on the 5th day of November, 1959, wherein said notice contained a brief description of the project, the total estimated cost of the project and the unit cost; the right for each property owner to be present and present objections, if any, at the public hearing to be held on the 9th day of December, 1959, at the hour of 7:15 p.m. in the Council Chambers of the City Hall in the City of Albany, Linn County, Oregon, be and the same is hereby ratified.
