Resolution No. 1759
(Adoption of a Committee for Citizen Involvement and Citizen Involvement Program for the City of Albany)

WHEREAS, the City of Albany has formally adopted a Neighborhood Planning Program (Resolution No. 1750) as the basis for creating a Committee for Citizen Involvement and Community-Wide Citizen Involvement Program, and

WHEREAS, each of the nine (9) separate neighborhoods within the existing Neighborhood Planning Program are currently organized as group associations and are functioning with officer and special committee representation, and

WHEREAS, it is the intent of the City of Albany to select the Planning Commission (9 members) and Chairpersons from each of the nine (9) neighborhood units (vice-chairperson to serve as an alternate member) to formally create and serve on the Committee for Citizen Involvement and that the existing Neighborhood Planning Program will continue as the Citizens Involvement program, now, therefore,

BE IT HEREBY RESOLVED that the City of Albany does formally adopt a Committee for Citizens Involvement and Citizens Involvement Program as required by the State Land Conservation Development Commission and the Citizens' participation goal.

BE IT FURTHER RESOLVED that the Committee for Citizens Involvement and Citizens Involvement Program will be responsible to the City Council for compliance with all State Land Use Goals and will be involved in all public hearing processes, review, amendments, data collection and recommendations in comprehensive planning and the review and recommendations for all implementing ordinances.

AGENCY INVOLVEMENT PROGRAM City of Albany (Adopted February 25, 1976)

The City of Albany recognizes its responsibility under the Statewide Planning Goals and Guidelines as adopted by the Land Conservation and Development Commission to prepare, adopt and implement a program for "Agency Involvement and Coordination." This program is intended to assure an effective working relationship with those local, state and federal agencies which may have an interest in the City and its surrounding area.

In order to fulfill this responsibility, the City has adopted the following agency involvement program:

- 1. The City will establish direct contact with the following agencies:
 - a. Local Agencies: Linn-Benton Housing Authority, Linn-Benton Intermediate Education District, Oregon District 4 Council of Governments, Linn-Benton Community College, School Districts 5 and 8, Grand Prairie School District, Linn County, Benton County and private Utility Companies (natural gas, power, water, telephone, solid waste disposal, etc.).
 - b. State Agencies: State Housing Division, Department of Economic Development, Department of Environmental Quality, Forestry Department, Department of Geology and Mineral Industries, Health Division, Division of State Lands, Public Utility Commissioner, Department of Transportation, Aeronautics Division, Highway Division, Parks and Recreation Division, Mass Transit Division, Office of Facilities Planning and State Board of Higher Education, Department of Water Resources, Department of Agriculture, Department of Energy, Intergovernmental Relations Division and Department of Fish and Wildlife.
 - c. Federal Agencies: U. S. Forest Service, Agricultural Stabilization and Conservation Service, Farmers Home Administration, Soil Conservation Service, Upper Willamette R. C. and D., Environmental Protection Agency, Bureau of Sport Fisheries and Wildlife, Bonneville Power Administration, Department of Housing and Urban Development, Bureau of Land Management, Corps of Engineers, U. S. Geological Survey and Pacific Northwest River Basins Commission.
- The City will inform the above agencies of the status of current planning efforts, future planning work schedules and regular meeting dates of the City Planning Commission and the City Council.
- 3. The City will provide to the various agencies, on request, copies of studies, plans and ordinances which are related to the City's planning program.

- 4. The City will request each agency to designate a contact person who will be responsible for coordination with the City.
- 5. The City will inform the various agencies of any other public hearings and/or other meetings when it is determined that it is in the interest of the City, the public and the particular agency to have notice of and the opportunity to participate in the meeting.
- 6. The City will request that each agency provide the information which is needed by the City to carry out its required planning program. This may involve such activities as follows:
 - a. Provision of plans or studies prepared by the agency which are needed by the City.
 - b. Participation by the agency in public hearings or other meetings.
 - c. Direct assistance by the agency in the development of a plan or study or in the consideration of a specific planning-related problem.
- 7. The City will use the services of the Linn-Benton Planning coordinator (Marvin Gloege) to facilitate intergovernmental coordination between the City and appropriate agencies and to assist in identifying and resolving conflicts.
- 8. The City recognizes the value of A-95 Clearinghouse review and other activities of Oregon District 4 Council of Governments and the State Intergovernmental Relations Division in enhancing needed intergovernmental coordination.
- 9. The City is presently cooperating with the Benton County Commissioners and the North Albany Advisory Group in an attempt to serve the North Albany area with sanitary sewers. It is expected that similar efforts will be undertaken with both Linn and Benton Counties in establishing an urban service boundary. The City has also participated in the coordination of a regional transportation study, to include two counties and several cities.
