SCHEDULE A Description of Activity

Present Status - Objective - Proposed Activity - Evaluation

PRESENT STATUS

A recent Roadway and Traffic Safety Study has determined that the City of Albany has a number of deficient traffic signs that should be corrected to provide for traffic and pedestrian safety. The deficiencies were caused due to the previous lack of technical staff that was needed to provide expertise in determining improper signing practices.

GOALS AND OBJECTIVES

The principal goal of the project is to correct those traffic sign deficiencies determined by a previous Roadway and Traffic Safety Program. The object of the project is to provide the necessary signing to reduce traffic accidents and to improve on pedestrian safety. A high priority will be given on correcting deficient school zone signing.

PROPOSED ACTIVITIES:

The project shall be divided in two phases. Work on each phase and specific task to be performed is described below:

Phase I. Obtain the Necessary Sign Materials Required

After obtaining funds through the Oregon Traffic Safety Commission, the project director shall order the sign material necessary to complete the project. Schedule for Phase I: Six to eight weeks are necessary to complete this phase.

Phase II. Installation of the Signs


The project director with the services of the City Public Services Department shall schedule the installation of the signs at their proper location according to the manual on uniform control devices. Schedule for Phase II: Six to eight months are necessary to complete this phase.

EVALUATION:

The project director will evaluate this work as it progresses to ensure the deficiencies are corrected in accordance with the City Roadway and Traffic Safety Program.

The project director will submit quarterly project evaluation reports to the OTSC by the 10th of the month following each calendar quarter during the project grant period.

After the project has been completed, the City will submit a final project report evaluating the benefits and effectiveness of work on the project as related to the principal goals and objectives. The format and general content of the evaluation report will be a part of the final project report and will include a specific plan for continuing effort.
