WHEREAS, a petition for the formation of the Linn Library District under ORS 198.705 to 198.955 has been presented for consideration to the Albany City Council; and

WHEREAS, it is anticipated territory within the incorporated limits of the city of Albany may in reason be served by facilities of services of the proposed District; and
