## EASEMENT FOR A SANITARY SEWER

THIS AGREEMENT, made and entered into this <u>16th</u> day of <u>December</u> 1982, by and between <u>Oregon Freeze Dry Foods, Inc.</u>

herein called grantors, and the CITY QF ALBANY, a Municipal corporation, herein called "City "

## WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey and transfer unto the City of Albany, an easement and rightof-way, including the right to enter upon the real property hereinafter described, and to construct, maintain and repair sanitary sewer lines for the purpose of conveying sewerage over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said sewer and the further right to remove trees, bushes, undergrowth and other obstructions interfering with the location, construction and maintenance of the said sewer.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

- a. a temporary easement which covers a strip of land <u>-0-</u> feet in width for the purpose of construction, and
- b. a permanent easement which covers a strip of land 12.00 feet in width for the purpose of maintenance;

over the property described herein.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for maintenance and repair purposes.
- 3. The land affected by this agreement is located in the County of Linn, State of Oregon; and is a portion of the tract as shown on the attached drawing, marked "Exhibit A," which is herewith made a part of this agreement.
- 4. The true, actual, and total compensation to be paid by the City to the Grantors, in exchange for the easement rights herein described and granted is:


