AGREEMENT FOR EASEMENT

THIS AGREEMENT, made and entered into this /2 day of August, 1985, by and between CCMW Company, a partnership comprised of Rex Casey, R. Verne Casey, Bernard Miller, and Larry Wabbs, together with Andrew and Tamara Antonson, hereinafter referred to as "The First Party," and the City of Albany, hereinafter referred to as "The Second Party."

WITNESSETH

(4) The Second Party hereby agrees to hold and save the First Party harmless from any and all claims of any third party arising from Second Party's use of the rights granted herein.


(5) The easement described herein shall be perpetual.
