EASEMENTS

CITY OF ALBANY, Oregon, a municipal corporation, Grantor, hereby grants to the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, Grantee, its successors and assigns, a permanent easement for the construction, reconstruction, operation, maintenance, and repair of a storm sewer, and appurtenances thereto, together with rights of ingress and egress thereto, over and across the following described property, to wit:

PARCEL 1

A parcel of land lying in the NE NW of Section 11, Township 12 South, Range 2 West, W.M., Linn County, Oregon; the said parcel being that portion of said NE NW lying Northerly of Wheeler Street; Southerly of a line at right angles to the "S" center line at Engineer's Station "S" 24+60 and included in a strip of land 20 feet in width, 10 feet on each side of said center line which center line is described as follows:
