#### EASEMENT FOR A SANITARY SEWER

THIS AGREEMENT, made and entered into this 31st day of January, 1986, by and between CASCADE WEST HEALTH SYSTEMS, INC., herein called grantors, and the CITY OF ALBANY, a Municipal corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair sanitary sewer lines for the purpose of conveying sewer over, across, through and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said sewer and the further right to remove trees, bushes, under-growth and other obstructions interfering with the location and maintenance of the said sewer.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consist of:

A 15-foot wide sanitary sewer easement. 7.5 feet on either side of a center line more particularly described as follows:

Beginning at a point on the west line of Block 42, City of Albany Addition, in the northeast quarter of Section 12, Township 11 South, Range 4 West, Willamette Meridian, City of Albany, Linn County, Oregon, said point being S 8° 16' E, 111.5 feet from the northwest corner of said Block 42; thence N 81° 49' E, 77 feet plus or minus to the ending point of the herein described easement.

- 2. The permanent easement described herein grants to the City, and to its successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for maintenance and repair purposes.
- 3. The true, actual, and total compensation to be paid by the City to the Grantors, in exchange for the easement rights herein described and granted is:
  - a. The approval of SP-04-86.
- 5. The City hereby covenants with the Grantors that the compensation agreed upon herein shall be paid to the Grantors within a period of thirty (30) days from the date of this instrument.
- 6. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will


