#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this <u>6th</u> day of <u>January</u>, 1988, by and between **Monty and Linda Ellison (Fmly Ltd Ptn) and James Gyovai**, herein called grantors, and the CITY OF ALBANY, a Municipal corporation, herein called "City."

### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, undergrowth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consist of:

A 5-foot wide permanent easement that is parallel, adjacent and south of the line described below and further shown on the attached drawing labeled EXHIBIT A.

Beginning at the northwest corner of that parcel conveyed to Monty and Linda Ellison, MF451-315 Linn County Deed Records, a portion of Lot 8, Block 81 of Monteith's Southern Addition to the City of Albany, Section 12, Township 11 South, Range 4 West, Willamette Meridian, Linn County, Oregon; thence Easterly on the north property line of said lot, 57.0 feet, to the intersection of the north property line with the east property line of said lot and there terminating






