WHEREAS, the City of Albany and Linn County have identified numerous roads under the jurisdiction of Linn County but within the limits of the City of Albany; and

WHEREAS; the City of Albany and Linn County have identified numerous bridges and structures which are under the jurisdiction of the City of Albany but within the limits of Linn County and outside the limits of the City of Albany; and

WHEREAS, the City of Albany and Linn County have entered into an intergovernmental agreement detailing the transfer of county roads to the City, and city bridges and structures to the County; and

WHEREAS, Linn County has agreed to pay to the City a total of \$2,865,350 at the completion of said agreement, \$530,000 of which will be deferred until the award of contract for the reconstruction of 7th Avenue and Broadway Street;

NOW, THEREFORE, BE IT HEREBY RESOLVED that the City of Albany requests that Linn County transfer jurisdiction of the roads shown on Attachment A to the City of Albany, and the City of Albany offers jurisdiction of the bridges and structures shown on Attachment A to Linn County and requests Linn County to accept such jurisdiction.
