A RESOLUTION APPROVING THE TRANSFER OF TITLE OF A PUBLIC SANITARY SEWER LINE FROM THE CITY OF ALBANY TO THE ARCHDIOCESE OF PORTLAND IN OREGON.

WHEREAS, a sanitary sewer line exists which solely serves the St. Mary's Church property located between Broadalbin Street and Ellsworth Street and being parallel to 9th Avenue, and

WHEREAS, the Archdiocese of Portland in Oregon is constructing a building on the St. Mary's Church property which will obstruct access to the sanitary sewer line and prohibit maintenance and repair of the sanitary sewer line, and

WHEREAS, it is in the best interest of the citizens of Albany to transfer title of this public sanitary sewer line to the Archdiocese of Portland in Oregon.

NOW, THEREFORE, BE IT RESOLVED by the Albany City Council that the transfer of title of the public sanitary sewer line located between Broadalbin Street and Ellsworth Street and being parallel to 9th Avenue to the Archdiocese of Portland in Oregon is hereby approved.




