#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 17th day of January, 1990, by and between Oregon Freeze Dry Foods, Inc. an Oregon Corporation, now known as Oregon Freeze Dry, Inc. an Oregon Corporation, herein called grantors, and the CITY OF ALBANY, a Municipal corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, under-growth, and other obstructions interfering with the location and maintenance of the said public utilities.

- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.


