#### DEDICATION DEED

KNOW ALL MEN BY THESE PRESENTS, that Mennonite Home of Albany, Inc., hereinafter referred to as the Grantor, does dedicate to the City of Albany for street and utility right-of-way purposes, all that real property situated in Linn County, State of Oregon, described as follows:

A variable width tract of land across that parcel of land conveyed to the Mennonite Home of Albany, Inc., in Volume MF 495, Page 59, Linn County Microfilm Deed Records, more particularly described as follows and as shown on the attached map label EXHIBIT A:

Beginning at the southwest corner of the Jordan S. Robinson Donation Land Claim Number 55 in Section 20, Township 11 South, Range 3 West, Willamette Meridian; thence on the centerline of Columbus Street,

North 00° 19′ 35" East 2,262.50 feet; thence South 89° 43′ 15" East 30.00 feet to the easterly right-of-way line of Columbus Street, said point being the TRUE POINT OF BEGINNING; thence on the easterly right-of-way line of Columbus Street, North 00° 19′ 35" East 358.09 feet, to a 5/8-inch iron rod at the most westerly northwest corner of Parcel A as shown on County Survey Number 19336; thence leaving said easterly right-of-way line, on the northwest line of said Parcel A, North 50° 01′ 22" East 844.19 feet, to a 5/8-inch iron rod on the southerly right-of-way line of the Southern Pacific Railroad; thence on said right-of-way line,

South 65° 30' 17" East 77.57 feet to a 5/8-inch iron rod; thence leaving said right-of-way line, South 50° 01' 22" West 670.69 feet, to a 5/8-inch iron rod; thence on the arc of a 575.06 foot radius curve to the left (the long chord of which bears South 25° 10' 28" West 483.30 feet) a distance of 498.79 feet to the easterly right-of-way line of said Columbus Street, said point being the True Point of Beginning.

and covenants that the Grantor is the owner of the above described property free of all encumbrances save and except reservations in patents and easements of record, and will warrant and defend the same against all persons who may lawfully claim the same.

Nothing herein shall reduce or limit grantors obligation to pay any costs or assessments which may result from the improvements.


