RESOLUTION NO. 3167

A RESOLUTION TO GRANT A UTILITY EASEMENT AT HENDERSON PARK TO U.S. WEST COMMUNICATIONS.

WHEREAS, U.S. West Communications has requested a 5' by 10' utility easement to be located in the southwest corner of Henderson Park; and

WHEREAS, the utility easement will allow U.S. West Communications to install a concrete pad and a metal cabinet to house telephone communication equipment; and

WHEREAS, there are no acceptable alternative locations for the utility box in the neighborhood area in question; and

WHEREAS, U.S. West Communications is willing to pay the City of Albany the sum of \$500 for the easement;

NOW, THEREFORE, BE IT RESOLVED that the City Council grants a 5' by 10' utility easement to U.S. West Communications provided that the following conditions are adhered to:

- 1. The concrete base for the utility cabinet be no larger than 4' square.
- 2. The dimensions of the cabinet be no larger than 5' high, 3' wide, and 18" deep.
- 3. Shrubbery be planted by U.S. West Communications around the cabinet to screen it from public view as approved by the Parks and Recreation Director.
- 4. U.S. West Communications shall pay to the City of Albany the sum of \$500 for the purchase of the utility easement.


