#### EASEMENT FOR PUBLIC UTILITIES

THIS AGREEMENT, made and entered into this 22 day of 500, 1992, by and between Curtis A. Myers and Margaret J. Myers, husband and wife, herein called Grantors, and the CITY OF ALBANY, a Municipal Corporation, herein called "City."

#### WITNESSETH:

That for and in consideration of the total compensation to be paid by the City, the grantors have this day bargained and sold and by these presents do bargain, sell, convey, and transfer unto the City of Albany, an easement and right-of-way, including the right to enter upon the real property hereinafter described, and to maintain and repair public utilities for the purpose of conveying public utilities services over, across, through, and under the lands hereinafter described, together with the right to excavate and refill ditches and/or trenches for the location of the said public utilities and the further right to remove trees, bushes, undergrowth, and other obstructions interfering with the location and maintenance of the said public utilities.

This agreement is subject to the following terms and conditions:

1. The right-of-way hereby granted consists of:

A 15-foot wide permanent public utility easement across that parcel conveyed to Curtis A. Myers and Margaret J. Myers, husband and wife, in MF Volume 603, Page 555, Linn County Microfilm Deed Records, being 7.5 feet on either side of the following described centerlines:

Beginning at a point on the north right-of-way line of Old Salem Road which point is 1951.62 feet South 1° 10′ West, 1341.60 feet North 79° 33′ East along the center of Salem Avenue to the southwest corner of that parcel conveyed to Warren M. Herbert et ux by deed recorded in MF Volume 474, Page 870, Linn County Microfilm Deed Records, 30.0 feet North 9° 55′ 10″ West along the west line of said Herbert parcel, and 8.48 feet North 79° 33′ East of the northwest corner of the Leander C. Burkhart Donation Land Claim No. 50, in Section 5, Township 11 South, Range 3 West of the Willamette Base and Meridian, City of Albany, Linn County, Oregon; and running thence North 7° 38′ 01″ West 153.94 feet to the center of a manhole; thence North 64° 07′ 57″ East 84.14 feet to the east line of Parcel 1 of Linn County Partition Plat 1992-25 and there terminating.

ALSO beginning at the center of the above mentioned manhole; thence North 24° 33′ 23″ West 16.43 feet to the north line of Parcel 1 of said partition plat and there terminating.

ALSO beginning at the center of the above mentioned manhole; thence South 64° 07′ 57" West 15.20 feet to the west line of Parcel 1 of said partition plat and there terminating.

Containing 0.088 acres, more or less.

2. The permanent easement described herein grants to the City, and to its

successors, assigns, authorized agents, or contractors, the perpetual right to enter upon said easement at any time that it may see fit, for construction, maintenance, evaluation and/or repair purposes.

- 3. The easement granted is in consideration of \$1.00 and in further consideration of the public improvements to be placed upon said property and the benefits grantors may obtain therefrom.
- 4. The Grantors do hereby covenant with the City that they are lawfully seized and possessed of the real property above described and that they have a good and lawful right to convey it or any part thereof and that they will forever warrant and defend the title thereto against the lawful claims of all persons whomsoever.
- 5. Upon performing any maintenance, the City shall return the site to original or better condition.
- 6. No permanent structure shall be constructed on this easement.
