WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Lewis R. Williams, Jr. and Oregon Department of Veteran's Affairs, hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by City of Albany, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Benton and State of Oregon, described as follows:

A portion of that tract of land conveyed by deed recorded July 9, 1980, and filed as Microfilm Record M-18498-80, Benton County Records, being within the Northwest 1/4, Southeast 1/4, Section 36, Township 10 South and Range 4 West of the Willamette Meridian in Benton County, State of Oregon, being more particularly described as follows: The westerly 8.00 feet of said tract. Containing an area of 1,145 square feet more or less.

Reserving onto the grantor, Lewis R. Williams, Jr., his heirs and assigns, a permanent easement for ingress and egress from his remaining property over and across the property above conveyed.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.
